Course Description: (from Eastfield Catalog):

Rehearsal and performance of brass ensemble repertoire, from 16th century to present. Ensemble skills including intonation, rhythm, phrasing, balance, style, and tone production will be studied.

Textbooks and Other Course Materials: Musical instrument and pencil.

Developmental Courses:

The Texas Success Initiative (TSI) is a statewide program designed to ensure that students enrolled in Texas public colleges and universities have the basic academic skills needed to be successful in college-level course work. The TSI requires assessment, remediation (if necessary), and advising of students who attend a public college or university in the state of Texas. The program assesses a student's basic academic skills in reading, writing, and math. Passing the assessment is a prerequisite for enrollment in many college-level classes such as English 1301/1302, History 1301/1302, Math 1414, etc. Students who do not meet assessment standards may complete prerequisite requirements by taking developmental courses in the deficient area and passing them with a grade of C or higher. In some cases retesting will also be required. It is up to each student to be aware and informed about requirements that are subject to change. **Additional information is available from the TSI Office.**

Course Objectives: Rehearsals are designed to familiarize the student with Brass Ensemble literature, strengthen skills in ensemble playing, and increase individual proficiency on the brass instrument. Periodic concerts will provide students opportunities for formal performance of finished works in public settings.

Student Learning Outcomes: During the semester, students will:

- Actively learn through rehearsing, performing, listening, discussing, watching and demonstrating concepts and styles related to brass instruments. Evidence will occur through discussions and performances of key concepts given by the instructor.
- Learn to provide artistic and entertaining performances brass ensemble literature for the Eastfield campus, community, and beyond. Evidence of this will occur in the students' ability to appropriately play and perform brass repertoire.
- Be encouraged to foster a lifelong interest for brass ensemble performance through resources as assigned throughout the semester. Evidence of this will occur through class discussions, rehearsals, and performances.
- Increase personal discipline, commitment, intellectual curiosity, and musicianship skills through the study of the art of music performance, by actively critiquing events in the learning process in and out of class and developing a problem-solving approach for the musical and technical needs of themselves. Evidence will occur in the students' musical execution on a weekly basis and in performance settings.

Evaluation Procedures:

Playing evaluation - 75%; Rehearsal and performance attendance - 25%.

Course Outline:

Twelve to sixteen musical works will be rehearsed and performed throughout the semester.

Attendance Policy:

Withdrawal Policy

STOP BEFORE YOU DROP

For students who enrolled in college level courses for the first time in the fall of 2007, Texas Education Code 51.907 limits the number of courses a student may drop.

You may drop no more than 6 courses during your entire undergraduate career unless the drop qualifies as an exception. Your campus counseling/advising center will give you more information on the allowable exceptions.

Remember that once you have accumulated 6 non-exempt drops, you cannot drop any other courses with a "W". Therefore, please exercise caution when dropping courses in any Texas public institution of higher learning, including all seven of the Dallas County Community Colleges.
